Our Clean Water program helped 59,087 rural Nicaraguans in 107 communities get access to safe water in 2014 through a low-tech and low-cost water chlorinator. Training, collaboration with local government, and a chlorine tablet distribution program ensures long-term access to water free of of microbiobial contamination.

4b (Code:) (Expenses \$ 44,882 including grants of \$) (Revenue \$ 36,591)
Renewable energy improves the health of the family and the environment. Biogas stoves and solar power reduce deforestation, increased air quality, and reduced the expense and time needed to cook and light homes for 437 Nicaraguans in a total of 72 homes in 2014.

4c (Code:) (Expenses \$ 20,517 including grants of \$) (Revenue \$ 17,965)
Through our Student Exchange Program, nine university engineering students and two engineering professors spent a month in Nicaragua working on developing prototypes for three different technologies, each with the goal of improving the quality of life for a family in Nicaragua. The technologies were a biochar reactor, a coffee roaster, and a household rainwater catch system. Not only do these designs stand to benefit the people of Nicaragua, this experience is beneficial for the American university students as well.
